About BYST

BYST is a not-for-profit organization that primarily assists disadvantaged Indian youth in developing business ideas into viable enterprises under the guidance of a mentor. Inspired by HRH, The Prince of Wales, and founded in 1992, Bharatiya Yuva Shakti Trust is the first organization to replicate the Prince's Trust's youth entrepreneurship support model globally outside U.K.

30 Years of Empowering Youths: Celebrating its 28 years of service to the nation and the youths of India, till date, BYST has supported its entrepreneurs with a total funding of about Rs. 539 crores through them 10% of BYST supported entrepreneurs have become millionaires. BYST through outreach and counselling initiatives has reached out to 10,30,223 youths. Many of BYST's entrepreneurs have gone ahead to win National and International awards and emerging as successful youth icons -72 National Awards and 29 International Awards.

BYST has expanded & set up regional clusters in NCR Delhi (Faridabad & Gurgaon), Tamil Nadu (Chennai), Maharashtra (Pune, Aurangabad and Wardha), Odisha (Jajpur & Rayagada), Rajasthan (Sikar), Uttarakhand (Udham Singh Nagar), Telangana (Hyderabad) and in the State of Assam.

International Presence: As a founding member of the Youth Business International (YBI), UK, BYST is helping to set up similar programmes globally, while enhancing its international linkages. Since 1994, BYST has helped set up programmes in Mauritius, Sri Lanka, Philippines, China and Nepal.

Mentoring- The BYST Way: Drawing inspiration from the ancient Guru - Shishya tradition, BYST has attracted top notch business leaders to act as volunteer mentor to the Entrepreneurs. A Mentor hand holds the entrepreneur for the first two crucial years of the business and if required continues thereafter as well. BYST mentor model has evolved over time to cater to entrepreneurs located in remote rural areas as well. Through innovations like mentor mobile clinics, BYST mentors from urban centers travel to the entrepreneur's location and provide advisory services right at their doorsteps. Most of the entrepreneurs mentored through BYST have to become role models and regional icons who are today guiding other entrepreneurs.

Mentoring India

BYST on the occasion of its silver jubilee, has unveiled a unique Programme 'Mentoring India' aiming to create a pool of mentors at every touch point such as financial and Government/Private institutions, where an entrepreneur currently interacts. Over 1964Mentors were trained and accredited by City and Guilds, the UK's largest and best-known vocational skills development and credentialing body.

BYST has been the first to successfully adopt and adapt a developed country model of mentoring-business advisory services through volunteer mentors to a developing country context. Using innovative schemes like mobile mentor clinics, the model has been adapted to work effectively in both urban and rural India. This developing country model is now being promoted in other developing countries around the globe. As BYST increased its scope, it developed an online mentor training programme that helps to virtually reach out to more mentors at any time and any place.

Support Services from BYST

BYST through its programmes supports underprivileged young entrepreneurs by supplementing financing based on the requirement assessment done by the mentor selectors, Rs. 5 lakhs being the present average and with an upper limit of Rs. 100 lakhs, they are also supported with a host of business-related activities such as training, business plan development, monitoring, mentoring and networking. The young entrepreneurs are nurtured till they reach a level where not only are they self-sufficient, but they in turn make a valuable contribution to society through creation of wealth and employment.

Mentor Development Program

With a mission to develop mentors from various touch points, BYST unveiled a brand-new Mentor Development Program for the officials from various institutions. This is two days of collaborative learning and sharing of ideas. The trainees were introduced to BYST programme. Then they had a hands-on experience with the Mentor Online Learning (MOL), an interactive online module. Each participant was guided through the 7 modules online. The BYST senior mentors and staff facilitated the participants to navigate the modules and complete the assessment.

The BYST entrepreneurs and their mentors shared their experiences with the participants. The participants were provided with a hands-on experience in counselling and guiding aspiring entrepreneurs along with a senior mentor. The practical sessions gave the trainee mentors an opportunity to learn by actually counselling and guiding the entrepreneurs. By the end of the training program, the participants were given a 360-degree practical exposure to the entire process of mentoring.

The trained "participants" who have successfully completed the Online Learning Modules and assessment will be certified from City and Guilds, UK, as "Accredited Mentors". The training will be followed by a one-year hand-holding period through which the mentors are engaged in a series of learning labs and networking activities.

BYST Selection and Screening Process

Awareness Generation Programmes - AGP

BYST conducts awareness generation for sourcing prospective entrepreneurs. For this, BYST has partnered with some NGOs and vocational institutes who source good entrepreneurs to us. BYST creates awareness about our programs through advertising in leading newspapers, Leaflet insertion in local newspaper hoardings. Banners and posters. Awareness Generation programs were conducted at different communities through various initiatives like outreach at market area, community visit, door to door visit, college presentations through Digital Platform (Zoho), AGP Through BYST Helpline Numbers, Whatsapp, SMS, During awareness generation programs the entrepreneurs are given a Digital form called 'Business Idea Generation" which is a structured questionnaire encompassing brief details of business plan, projected loan amount required and details on personal profile.









When the youth entrepreneur's approach BYST with their business ideas, they are counseled by mentors/counselors on one-to-one basis, Three-way call, Zoho. Once they meet the eligibility criteria and have a viable business proposition they are referred to the next stage i.e. Entrepreneurship Online Training Those applications which are found ineligible as per BYST criteria are signposted to Skill Development Institutions, financial institutions and other voluntary organization

This year special counselling weeks were conducted through digitally during covid-19 and to enhance the walk-in of potential entrepreneurs at BYST office Bhubaneswar and Ranchi. Potential entrepreneurs from various blocks/wards across the operational areas attended and were counselled by Mentors of BYST.

Counselling / Screening


After the prospective entrepreneur's approach BYST with their business ideas, the application is screened, and youths are counselled by mentors/counsellors. During this process, the youth are counselled one-to-one to select them for the next stage-training.





Smart Training for Enterprises Planning

Selected candidates undergo a free EDP Training Program (Entrepreneur Online Learning – EOL) to enable them to fine tune & covert their ideas into concrete business plans. Training is provided for 2-3 days where the selected entrepreneurs are briefed on the basic concept of entrepreneurship; Banking practices, customer relations, accounts keeping, project preparation and soft skills on art of selling, etc, this year 80% training we have been conducted digitally through Microsoft team.



Business plan and Documents Collection

BYST helps in the initial formulation of the business plan. For the same, collection of documents from entrepreneurs is done by BYST officials. Visits are made by the BYST officials to the entrepreneurs' business unit and home (for site verification and meeting the family members) and verification of all documents in original.



Entrepreneur selection

BYST's empaneled Mentors/Experts will rigorously evaluate the trained candidates and their preliminary proposals, and select potentially viable projects. BYST will assist potential entrepreneurs to prepare bankable project proposals.



Internal Entrepreneur Selection Panel (IESP)

BYST has a panel of members. (Volunteers from industry, financial institutions, successful entrepreneurs etc). This panel interviews the entrepreneurs on all the aspects of business and accordingly recommends for the next step.

Bank Entrepreneur Selection Panel (BESP)




The BESP is a joint panel, which comprises officials representing BYST and at least two officials representing the Bank with one member having the authority to sanction the loan. Once the IESP recommends the cases, the proposals along with the other documents (report on site verification, technical evaluation, etc) are submitted to the BESP. The BESP finally recommends the proposals for sanctioning.

Financial Assistance

Financing by partner bank: BYST provides financial assistance through its financial partners. BYST is having a pan-India MOU with State Bank of India, Indian Bank, Bank of Baroda (BOB), Indian Overseas Bank (IOB), BharatiyaMahila Bank (BMB), Bank of Maharashtra (BOM) and IDBI to support the entrepreneurs selected by BYST. After the business plan, along with financial projection is made, BYST submits the cases to bank for financial support.

Mentoring: This is the unique feature of BYST programme where each entrepreneur is assigned a mentor who monitors the progress of the business, helps in solving problems and developing business until the business becomes sustainable. Once the loan is disbursed, a mentor is allotted to each entrepreneur to handhold them for a period of two years.





Mentor Mentee First Meeting

The Mentor Advisory Panel (MAP) allocates a mentor to the Internal Entrepreneur Selection Panel (IESP) approved entrepreneur according to the mentor and mentee's geographical area and area of expertise. Once the allocation process is over, BYST arranges the first mentor-mentee meeting at office/entrepreneur's unit/mentor's place/chapter meeting. The mentor-mentee first meeting is very vital for an initial interaction and building relationship between the entrepreneur and mentor. This helps the mentor to understand the entrepreneur's project and business, which they are going to start up. It also helps the mentor for providing further guidance to the entrepreneurs.



Mentor Mobile Clinic





While entrepreneurs are based at far-flung villages, the mentors invariably live and work in the urban areas. This makes the regular one to one interaction very difficult. To overcome this challenge, BYST has the concept of Mentor Mobile Clinic, where a group of expert mentors visit entrepreneur business units and interact with the entrepreneurs and give expert advice on all issues that they may have.

Monitoring Visit

Monitoring and Business Performance Tracking Form (BPTF) collection is a regular practice of BYST. After getting financial support, the entrepreneurs are continuously monitored by the assigned mentors along with BYST staff.



This includes filling up of BPTF, first mentor-mentee pairing, and mentor mobile clinic. This regular monitoring helps in keeping track of the business progress and triggering any issues before they become big problems.

Mentor Chapter Meeting



Mentor chapter meeting serves as a link between the entrepreneur and the mentor. The mentors network and share experiences with their peers on how to improve the mentoring services.

To facilitate the effective mentoring, every month the chapters hold the chapter meeting where discussions take place on various topics like development, planning for future activities, target vs. achievements, facilitation of networking among members and interact periodically with Entrepreneurs. The meeting has a standard agenda for the first part to comply with basic requirements and structure the second part with flexibility to include Mentor Mentee Presentation, outside speakers, presentation on a topic of related interest by a mentor. All mentee are invitees to the chapter they belong.

The chairman updates the chapter performance Targets and plans for the year. Various suggestions are taken from the members which includes inviting expert speakers, entrepreneurs to share their problems and experiences, Partner NGO/Banks for presentation, brainstorming and Joint meeting with other Chapters.

Post Loan Training

To enable handholding support and sustainable development of entrepreneurs, BYST conducts post loan training for the supported entrepreneurs after financial aid disbursement. All training programmes include various topics on post loan activities such as:

- Marketing challenges for small businesses
- Sourcing the target group of customers for business
- Using marketing techniques without spending money for marketing of products
- Providing value addition to the products to the utmost satisfaction of the customer without reduction in the price of their products



Showcasing Success

Lalita - Igniting the flame of women entrepreneurship in rural Mind!!



Lalita Debi, a young widow from Amlabhata, a remote tribal village in Rayagada district, Odisha found life a struggle after the sudden demise of her husband. Left to feed and care for her three school going children, Lalita was extremely distressed. While her husband was alive, Lalita never felt the need to work outside the home. But suddenly, fate had thrust her into a role of the sole bread winner of the family.

Lalita managed to do some odd jobs but the paltry sum that she earned from these were not adequate to manage her family. She wanted to provide education to her children at all costs, but also realized that by doing low paying manual jobs is not going to help her.

At this time, she learnt about making paper plates and decided to start a paper plate manufacturing business. The idea of being her own boss as well as providing employment to other women motivated Lalita. However, soon Lalita found out that mere skill or a business idea is not enough to become a successful

entrepreneur. There were many who kept discouraging her and she had to face severe challenges in her quest to start her own business.

Kiranbala Chowdhury – Making an impact in the food industry



Kiran had a difficult childhood after her father's death. Her mother singlehandedly raised both the children giving them all care and attention. Kiran was a very ambitious girl and interested in studies. As both children grew older, her brother's education took precedence because their mother could only afford one child to attend college. So, Kiran had to abandon her plans to pursue her graduation and allow her brother to move ahead.

Her mother married her off when she was 18 years old, much against her wishes. She married and raised two wonderful children in Bhubaneswar. That was the end of Kiran's ambitions and dreams. Her in-laws were far too conservative to allow her to continue her education.

Being a strong-willed lady, she did not give up. Her husband, sensing her desire to excel in life, constantly supported her endeavors. He encouraged her to join his small eatery business, which was a blessing in disguise for Kiran. She was a quick learner and gained good knowledge and skills to run the business in a short time.

She decided to start her venture to manufacture Indian snacks when her husband's eatery business was severely impacted by the pandemic. She approached many banks for loansbut was always turned down. She contacted BYST on the advice of a friend, and they put her through their entrepreneurship training program. Following the program, BYST assisted her in obtaining a loan from the State Bank of India for Rs. 23 lakh. With her hard work and never give up attitude, Kiran's venture, "Som Veg," clocks a monthly turnover of Rs. 3 lakhs in just over 19 months.

Arun Awtade - Nurturing environment in natural ways



ArunAwatade was born into such a remote drought-prone village in the Sholapur district of Maharashtra. He is the older of two brothers. Arun's parents migrated to Pune due to a severe drought in the 1970s that forced many to starve, die of hunger or by suicide. In Pune, his parents had to take up many odd jobs to sustain the family, but always encouraged the brothers to complete their education.

Having grown up in extreme poverty with a ringside view of the impoverished condition and struggles of similar landless laborers and farmers in his community, Arun was always driven by the desire to bring about a lasting change. When he completed his education, he worked some part time jobs, all the while looking for ways to start a business. He always knew that his business would be based on conserving the water and helping the farmers, so that they stop migrating, starving, or killing themselves. He continued his research on alternative and sustainable agriculture practices while he worked to save up some capital.

After much research, he found that the mulching technique could become the answer to his question. Mulching helps conserve water, improve the quality of soil, prevent the use of pesticides, cut down labour costs, and also keeps the soil healthv.

However, Arun lacked the resources to develop his idea into a viable venture. He had no idea about developing a business or about the schemes he could apply for. He approached many banks, but they refused to give him a loan without collaterals. Almost two years went by looking for capital and he managed to raise just adequate funds by conducting

tuitions in his spare time. With a small investment of Rs. 40,000 Arun started the business with reconditioned scrap machinery and roped in his childhood friend Ganesh to help him in 2010. But he could not sustain it for a long time.

But they say that good things happen to good people. And by a stroke of luck, Arun came across a BYST post at a bus stop, and his life changed. In 2012 Arun was introduced to BYST who assigned a mentor to guide him and also facilitated bank financing to launch his business.

Today, his company Iris Polymers based in Pune, is one of the leading manufacturers of mulching film and eco-friendly packaging solutions. With the knowledge and experience that BYST shared with him, Arun has expanded his business to include different types of mulching film including Silver Black, Light Black, Yellow Black, White Black, and Red Black. Currently, Iris Polymers has operations across Maharashtra and three other states and is now looking to expand internationally. The company employs 53 personnel and has an impressive turnover of INR 22 crore annually.

His work earned him the Youth Business International Social Entrepreneur Award in 2015. Over all these years, not much has changed in his attitude towards the reason why he chose this business, or the people he employed, or the community he wishes to serve through his business. That is why, even when business suffered during the pandemic, Arun did not remove any of his staff members. Now that his business has picked up pace again, he has managed to overcome all loses.

Mangesh Chavan - Epitome of Artist



Mangesh comes from a rural family where both his mother and father work as farmers to support the family. He has two younger siblings. Mangesh's father had taken loans from the money lenders to support the family. Despite of the financial crunch in the family Mangesh's father took great efforts to send his children to school. Being the older son, Mangesh was totally aware of the situation and wished to improve the status of the family. He studied with determination and went on to Pune & Mumbai for pursuing his higher education.

Having finished his HSC from the village, even though Mangesh had greater ambitions to pursue he convinced himself to complete a 2-year arts course in 2006. Post which he completed a 4 Year G. D ART Course and Diploma in Art education. Eventually he was employed by a tile manufacturing company. Through his earnings Mangesh managed to pay back the loans his father had taken from the money lenders. While he was working in the company for over 2 years, Mangesh's efforts & hard work were hardly acknowledged & appreciated. He quit the job and started his own manufacturing unit of (Ganpati) statues namely "VighnahartaKalaniketan" in 2013. He uses eco-friendly soil to make all his statues and never compromises on the quality. He infact buys the soil from Gujarat and other raw material like color, spray, painting brush from the local market of Mumbai. He finishes off every single murti by himself thus delivering stellar quality products. Each year his company sells over 7000 murtis with a turnover ranging from 20 to 25

lakhs. He supplies all over the state of Maharashtra. Mangesh learnt about BYST through a friend and approached the Pune chapter. He was then counselled, trained and supported with further financial assistance to expand his business. With the guidance of BYST and its training programs he improvised his digital marketing & advertising strategies. He took efforts to sell his products online, and thereby reaching thousands of customers. With his success in the business Mangesh managed to build his own house in Pune and went on to buy a 2000 sq. ft of land for his business unit. He further has plants to build a warehouse to contain his large murtis/products. Hailing from an economically disadvantaged background, Mangesh is socially responsible and wishes to reciprocate to the society. He has trained and employed over 15 women employees from the locality into his unit. He also supports them financially during turmoil.


